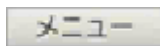

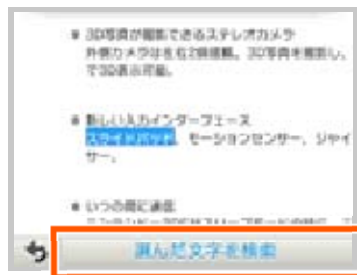

画像の表示と保存について

ホームページに表示されているJPEG画像をしばらくタッチし続けたり、JPEG画像へのリンクをタッチしたりすると、上画面に画像が表示されます。下画面の『画像を保存』ボタンをタッチすると、上画面に表示されている画像をSDカードに保存できます。

- 保存した画像は、ニンテンドー3DSカメラで見ることができます。日付情報がない画像は、「1900/1/1」の日付で保存されます。
 - インターネットブラウザに対応した3D画像を、表示したり保存したりすることもできます。

Preamble

The licenses for most software are designed to take away your freedom to share and change it. By contrast, the

GNU General Public Licenses are intended to guarantee your freedom to share and change free software--to make sure the software is free for all its users.

This license, the Library General Public License, applies to some specially designated Free Software Foundation software, and to any other libraries whose authors decide to use it. You can use it for your libraries, too.

When we speak of free software, we are referring to freedom, not price. Our General Public Licenses are designed to make sure that you have the freedom to distribute copies of free software (and charge for this service if you wish), that you receive source code or can get it if you want it, that you can change the software or use pieces of it in new free programs; and that you know you can do these things.

Preamble
